Obligations and responsibilities

Under this agreement, the booking party undertakes to :

- ensure that the proposed activity runs smoothly,
- leave the premises in a clean condition after use (wipe down the tables, sweep and wash the floor), otherwise a cleaning charge of 50 euros will be deducted from the deposit.
- use cups/glasses/plates and put them in the dishwasher after use, otherwise a cleaning fee of 50 euros will be deducted from the deposit.
- use the premises with due regard for public order, hygiene and morality, and to ensure that safety instructions are observed,
- use the premises and equipment made available with due care and attention, in accordance with the purpose for which they were provided, and without doing anything that might disturb the peace and good order of the neighbourhood,
- to deal personally with any claims or disputes from third parties concerning his activity.

The use of any electrical equipment must be expressly authorised in advance, to avoid causing network breakdowns.

The booking party is personally liable to the owner of the premises, its users and third parties for any damage caused by him or his guests. He will be liable for any damage caused to the premises during the time he is in possession of them and committed by him or by his guests. He will not be able to exercise any recourse against other parties in the event of theft, burglary or disturbance of the use of the premises caused by himself, other users or any other person, and will be personally responsible for taking out any insurance in this respect.

The booking party stops all loud noises at 10 p.m. and refrains from any disturbance of public order under the terms of the general police regulations of 26 March 2001 as amended on 23 November 2015.

The premises must be returned to their original state no later than 10 hours after the end of the activity, unless otherwise agreed in writing. All glass bins must be removed by the booking party and may under no circumstances be left on the premises, failing which a disposal fee of 100€ will be applied. If the keys are lost, a refund of 50 € will be charged.

The booking party undertakes to keep the **environmental impact** of his activity to a minimum by avoiding the use of packaging, decorations and single-use crockery. He is actively involved in finding and sharing equipment that can be shared.
